## **BUSINESS MANAGER'S REPORT**

Sisters and Brothers, as I sit here and write this article for the Conduit, Memorial Day has just passed and the start of summer has now arrived. The work picture is really starting to pick up. We now have full employment and have started putting out some travelers off of Book 2. We should continue to put out travelers for the rest of the summer and even into the fall with

some of the big projects not even manning up yet. Some big projects that will be taking manpower this summer and fall are the Belmont Racetrack, Jakes 58, South Shore Hospital, Brookhaven Landfill Solar Farm, Sunrise Wind Converter Station and Duct Bank, Cold Spring Harbor lab project, plus many large residential projects.

Recently we just finished negotiating three contracts. The Maintenance, Pump and Tank and the Telephone contracts. All three contracts were unanimously ratified by the members of those units. The Maintenance and Telephone units negotiated a three-year contract with an 11.5% increase on the package over the three years. The Pump and Tank unit negotiated a five-year contract with an 19.9% increase on the package over the five years.

Some recent conferences that have just passed and that are coming up are the IBEW Construction and Maintenance Conference and National Building Trades Conference, which were held in April, and both were held in Washington, DC. The IBEW Telephone Conference and the National Offshore Wind Conference were also held in April. Coming up this week is the NY Business Managers' Meeting which is held in Albany twice a year. That should be it with the conferences until August when the IBEW Membership Development Conference is held.

We are just about finished with the renovation of the union hall. We took out all the old Belgium block planters, had the hall painted, put all new porcelain tile down in the back of the hall, and just finished putting down new carpet in the front of the hall. The last thing that needs to be done is to replace the bar. The old bar was rotted out and falling apart. The new bar should be installed sometime at the end of July. We have been in this building for 32 years now and we have been slowly doing some renovations to it the last couple years. It feels like yesterday that we moved from the old hall on Pinelawn Road in Melville. The class of 1991, which was my apprenticeship class, was the last to graduate from the old hall.

Brothers and Sisters, that ends my report for this issue of the Conduit. Remember to work safe, turn off energized circuits and always remember to stick together out there.

- Magellan Rx/Prime is also your provider for Mail order prescription fills.
  <u>Note:</u> on the 3<sup>rd</sup> fill and thereafter of maintenance medications, there is a 40% co-insurance (at the pharmacy) if the medication is not filled via mail order. So, it pays to use the mail-order option, because the co-insurance is 20% via mail order. This has always been the case.
- Some specialty medications <u>MUST</u> go through the cost mitigation program provided by Payer Matrix. If you are prescribed an eligible specialty medication, you will be contacted by Payer Matrix to assist you with getting your prescription. Please provide the information that they request, it is part of the process and is <u>confidential</u>. The information that you provide helps Payer Matrix source funding for the medication which could result in savings. Your medication will be filled only after the information is provided to Payer Matrix. Please note that Payer Matrix is in place to save you and the Fund money.



## NEC CODE CORNER

This month we will continue to examine the **2023 National Electrical Code, Part II. Branch Circuit Rating, 210.18 Rating.** This section has added a 10 ampere rating or setting of the overcurrent device. As energy codes are updated because of the use of energy-efficient lighting, including LED's, a public input was submitted that established the 10-ampere branch circuit. The 2023 edition of the National Electrical Code has specific language concerning many types of installations. Remember to consult the code book for additional information. The **Outline and Language** of the code is included below. Practice using the Codeology Method to answer all your code challenges.

#### CHAPTER, ARTICLE, PART, and SECTION!

#### 2023 National Electrical Code

<u>Chapter</u>	2 Wiring and Protection
<u>Article</u>	<b>210 Branch Circuits</b>
<u>Part</u>	II. Branch-Circuit Ratings
Section	210.18 Rating

#### 210.18 Rating.

Branch circuits recognized by this article shall be rated in accordance with the maximum permitted ampere rating or setting of the overcurrent device. The rating for other than individual branch circuits shall be 10, 15, 20, 30, 40, and 50 amperes. Where conductors of higher ampacity are used for any reason, the ampere rating or setting of the specified overcurrent device shall determine the circuit rating.

Exception No. 1: Multioutlet branch circuits greater than 50 amperes shall be permitted to supply nonlighting outlet loads in locations where conditions of maintenance and supervision ensure that only qualified persons service the equipment.

Exception No. 2: Branch circuits rated 10 amperes shall not supply receptacle outlets.

#### So what does this mean?

Section 210.18 now allows 10-ampere individual branch circuits to be used in permitted locations. The electrical industry is promoting the use of energy-efficient lighting, and the updating of energy codes reflect these changes. With lower amperage values on certain branch circuits, it makes sense to update the NEC to allow lower amperage rated overcurrent protection devices; fuses and fixed-trip circuit breakers to protect these circuits. During an **overcurrent** condition; overload, short-circuit or ground fault, the overcurrent device will react more quickly with a lower overcurrent protective device rating when that device rating is exceeded, reducing the damage to the conductors and equipment. Exception No. 2 points out that branch circuits rated 10 amperes shall not supply receptacle outlets because of a concern that utilization equipment could be plugged in that would exceed the rating of the branch circuit.

It is important to review Article 100 Definitions, to understand defined terms and their meaning when applying the NEC.

## **Branch Circuit, Individual**. (Individual Branch Circuit)

A branch circuit that supplies only one utilization equipment. (CMP-2)

#### Ground Fault.

An unintentional, electrically conductive connection between an ungrounded conductor of an electrical circuit and the normally noncurrent-carrying conductors, metal enclosures, metal raceways, metal equipment, or earth. (CMP-5)

#### Outlet.

A point on the wiring system at which current is taken to supply utilization equipment. (CMP-1)

## NEC CODE CORNER

#### (Continued)

#### **Overcurrent**.

Any current in excess of the rated current of equipment or the ampacity of a conductor. It may result from overload, short circuit, or ground fault. (CMP-10)

#### Overload.

Operation of equipment in excess of normal, full-load rating, or of a conductor in excess of its ampacity that, when it persists for a sufficient length of time, would cause damage or dangerous overheating. A fault, such as a short circuit or ground fault, is not an overload. (CMP-10)

#### **Receptacle Outlet**.

An outlet where one or more receptacles are installed. (CMP-18)

#### Short Circuit.

An abnormal connection (including an arc) of relatively low impedance, whether made accidentally or intentionally, between two or more points of different potential. (CMP-10)

#### **Utilization Equipment**.

Equipment that utilizes electric energy for electronic, electromechanical, chemical, heating, lighting, or similar purposes. (CMP-1) The 2023 edition of the National Electrical Code certainly meets the purpose of the code – sensible revisions reflecting advances in technology along with industry practices for the practical safeguarding of persons and property from hazards arising from the use of electricity.



# Local 25 Sportsman's Club


