Ten years ago, Local 25 members Tim McCarthy and Joseph Morici founded what would become the first successful Local 25 ice hockey team. In those early seasons, the team quickly exceeded expectations, consistently reaching the playoffs—though falling short of a championship title.

As the team grew in talent and chemistry, that elusive championship finally came. Fueled by momentum and a shared drive to succeed, the team captured another title, then moved up a division. And then another. And another. Each step up marked progress built on hard work, perseverance, and unity.

One dream remained: representing Local 25 in the IBEW hockey tournament in Canada. That dream became a reality two years ago, thanks to overwhelming support from union brothers and sisters, as well as strong backing from President John Guadagno and Business Manager Kevin Casey. With dedicated fundraising and commitment, the team headed to Canada with pride and purpose.

Despite falling just one point short of the playoffs, the team's performance was anything but a failure. The 25ers played with heart and honor, representing Local 25 with distinction. Still, for many of the players, the trip left unfinished business—they weren't satisfied with falling short. They had something more to prove.

This year, the 25ers returned to Hamilton, Ontario with that mission in mind. Backed by the unwavering support of Local 25, the team was determined to finish what they had started. They went undefeated in the round-robin stage, finishing 3–0, and continued their dominance with a strong playoff performance in Game 4.

With momentum on their side, the 25ers entered the finals ready for battle—and they delivered. Every player gave their all, every shift, and they defeated Toronto in the championship game, completing a perfect 5–0 tournament run. Their efforts earned them six separate tournament trophies and, more importantly, the title of IBEW champions.

In the aftermath of the win, the team reflected on their journey—from humble beginnings to achieving a dream ten years in the making. Several original members were still with the team, now champions on the international stage.

Since their formation, the 25ers have captured numerous titles, including five in just the past two years. They now compete in the second-highest division on Long Island, but the IBEW championship stands above them all.

What started as a simple game on ice—with sticks, skates, and a dream—has grown into something far greater: camaraderie, brotherhood, and pride. We will never forget what we achieved, or the support that made it possible.

NEC CODE CORNER

This month we will continue exploring the 2023 National Electrical Code, particularly Article 555 Marinas, Boatyards, Floating Buildings, and Commercial and Noncommercial Docking Facilities, Section 555.36 Disconnecting Means for Shore Power Connection(s), (C) Emergency Electrical Disconnect. This significant change adds new language at this subdivision to require an emergency disconnect be located within sight of a marina power outlet or enclosure that provides shore power to boats. If a swimmer is exposed to electrical current in the water and struggling to stay alive, disconnecting the boat nearest the swimmer is critical, due to very little time to act before the swimmer goes under water and drowns. This emergency disconnect, located at each boat slip, can be effective at saving the lives of Electric Shock Drowning (EDS) victims and rescuers, without having to shut down the entire marina. The 2023 edition of the National Electrical Code has specific language concerning many types of installations. Remember to consult the code book for more information. The **Outline** and Language of the code is included below. Practice using the Codeology Method to answer all your code challenges.

Disconnecting means shall be provided to isolate each boat from its supply connection(s).

(C) Emergency Electrical Disconnect.

Each marina power outlet or enclosure that provides shore power to boats shall be provided with a listed emergency shutoff device or electrical disconnect that is clearly marked "Emergency Shutoff" in accordance with **110.22(A)**.

The emergency shutoff device or electrical disconnect shall be within sight of the marina power outlet or other enclosure that provides shore power to boats, readily accessible, externally operable, manually resettable, and listed for use in wet locations. The emergency shutoff device or electrical disconnect shall de-energize the power supply to all circuits supplied by the marina power outlet(s) or enclosure(s) that provide shore power to boats. A circuit breaker handle shall not be used for this purpose.

So what does this mean?

Section 555.35 Ground-Fault Protection of Equipment (GFPE), requires ground-fault protection for docking facilities shall be provided in accordance with 555.35(A) through (D). Section 555.35(A) Feeder, requires Listed GFPE, rated not more than 100 milliamperes, shall be provided for feeders installed on docking facilities, and section 555.35(B) Branch-Circuits, 555.35(B)(1) Receptacles Providing Shore Power requires Listed GFPE, rated not more than 30 milliamperes, shall be provided for Shore Power Receptacles (555.33(A)). It is important to remember that if the leakage current (low fault current value) is less than 30 milliamps on a branch circuit or less than 100 milliamps on a feeder, the GFPE device will not interrupt the flow of electrons supplying the device.

Reviewing two **Article 100** definitions:

Ground-Fault Circuit Interrupter (GFCI).

A device intended for the protection of personnel that functions to de-energize a circuit or portion thereof within an established period of time when a ground-fault current exceeds the values established for a Class A device.

Informational Note: Class A ground-fault circuit interrupters trip when the ground-fault current is 6 mA or higher and do not trip when the groundfault current is less than 4 mA.

Ground-Fault Protection of Equipment (GFPE).

A system intended to provide protection of equipment from damaging line-to-ground fault currents (Continued on next page)

by operating to cause a disconnecting means to open all ungrounded conductors of the faulted circuit. This protection is provided at current levels less than those required to protect conductors from damage through the operation of a supply circuit overcurrent device.

A Ground-Fault Circuit Interrupter (GFCI), is a device intended for the protection of personnel and Ground-Fault Protection of Equipment (GFPE), is a device intended for the protection of equipment. It has been established for humans that the nolet-go threshold happens at about 10 milliamps, GFCI protection for personnel happens in the 5 milliamp range (+/- 1mA) and GFPE protection of equipment happens at 30 milliamps and above, depending on the fixed or adjustable GFPE value. Devices operating at current levels higher than those specified for a Class A GFCI do not provide GFCI protection of personnel, but they will open the circuit at much lower levels of ground-fault current than will a standard overcurrent protection device (OCPD). While the ground fault protection of equipment may provide some protection to swimmers in the water away from an energized boat or dock, it will not provide electric shock protection for a swimmer touching an energized metal boat, dock or ladder. When a swimmer feels the sensation of electrical current in the water, their survival instinct is to swim to the nearest boat or dock to get out of the water, and that could be fatal. An emergency disconnect located on the marina outlet or enclosure providing shore power to a boat, will allow observers to quickly de-energize power to the boat and dock nearest the swimmer and give the swimmer or rescuer a chance to live and not disrupt the entire marina operation. When leakage current occurs at marinas and swimmers are subjected to electric shock drowning, this shore power disconnecting means requirement will save lives. The 2023 edition of the National Electrical Code certainly meets the purpose of the code – sensible revisions reflecting advances in technology along with industry practices for the practical safeguarding of persons and property from hazards arising from the use of electricity.
