
On the home front, we completed our new Executive Board room with a new horseshoe desk, cabinets, paint, carpet, and lighting.

### **Remember Care Packages from Home?**

If you ever served far from home, you probably remember that feeling — the mail call moment when someone shouted your name and a box showed up with your handwriting on it. Inside might be cookies that didn’t quite survive the trip, a letter smudged with coffee, or just something small that reminded you the world hadn’t forgotten. Those packages carried more than stuff — they carried care, humor, and the steady reminder that someone was thinking of you.

These days, most of us aren’t waiting on mail calls, but that spirit of sending something from the heart still matters. The holidays can get expensive fast, and store-bought gifts often miss the mark. But there’s something timeless about a homemade gesture — something you can touch, smell, and share. That’s why sim-

ple, budget-friendly ideas like layered brownie mix jars have made a comeback: they’re easy to assemble, look great, and hit that same old-school note of comfort.


To make your own, layer 1 cup sugar, ½ cup cocoa powder, ½ cup flour, ½ teaspoon salt, ½ teaspoon baking powder, and ½ cup chocolate chips in a quart-sized mason jar. Gently tap the jar between layers to settle the ingredients and create clean, visible stripes. Screw on the lid and dress it up with a bit of ribbon, twine, or fabric over the top. Then add a tag with the baking directions: “Add ½ cup melted butter, 2 eggs, and 1 teaspoon vanilla. Bake at 350°F for 25–30 minutes.” It’s simple, heartfelt, and the kind of thing that reminds people — just like those care packages — that a little thought goes a long way.

# NEC CODE CORNER

**New York State** has made it official! The State will begin **enforcing** the **2023 National Electrical Code**, with an official **effective date** of **December 31, 2025**. At the July 25th Code Council meeting, the **New York State Code Council** voted to **adopt** the **2025 Uniform Fire Prevention and Building Code**, which references the 2023 NEC. The official announcement was published in the October 1st edition of the **New York State Register**, on page 25, under **Notice of Adoption**, The Uniform Fire Prevention and Building Code, known as the Uniform Code. The council **repealed** the previously adopted 2020 Uniform Code, which references the 2017 NEC, and **adopted** the new 2025 Uniform Code, referencing the **2023 NEC**. This means that all electrical installations with a building permit issued on or after December 31, 2025, must comply with the 2023 NEC. Building permits issued before December 31st can continue to use the 2017 NEC, without needing to follow the 2023 NEC. The 2023 edition of the National Electrical Code has specific language concerning many types of installations. Remember to consult the code book for additional information. Practice using the Codeology Method to answer all your code challenges.

## CHAPTER, ARTICLE, PART, and SECTION!

### So what does this mean?

The **New York State Code Council** appears to be establishing a pattern, and it certainly is a challenging one. Remember back in 2020 when the 2017 NEC was required to be enforced by the State? Beginning in May of 2020, New York State mandated the use of the 2017 NEC for installation and enforcement. Although the Council skipped the adoption of the 2014 NEC, the changes from 2011 to 2014 applied as well as the changes from 2014 to 2017. That is two cycles of many significant changes to become familiar with. The **National Fire Protection Association** marked up the 2017 NEC with grey shading to indicate changes in the code from the 2014 edition, but what about the changes in the code

from 2011 to 2014? That would require the 2014 edition of the NEC with the grey shading indicating those changes.

Now, the New York State Code Council has done it again. This is the pattern I am referring to. The Code Council is moving on from the 2017 NEC and **adopting the 2023 NEC** for installation and enforcement, again two cycles worth of changes. The Code Council skipped the adoption of the 2020 NEC, but the many changes from 2017 to 2020 still apply just as the many changes from 2020 to 2023 now apply too. The **NFPA** uses a variety of methods to indicate changes from one edition of the NEC to the next edition: shading, small triangles, bullets in the left margin of the page, and the letter "N", but only in three-year cycles. Once again the 2020 NEC shading will indicate the changes from 2017, and the 2023 shading will indicate the changes from 2020.

This example shows how **210.8 Ground-Fault Circuit-Interrupter Protection for Personnel** has changed in the 2017, 2020, and 2023 NEC.

- The **2017 NEC** states - Ground-fault circuit-interrupter protection for personnel shall be provided as required in **210.8(A)** through **(E)**. Letters **(A)** through **(E)** are first level subdivisions, so five subdivisions, with the letter **(A)** applying to **Dwelling Units**, containing nine list items, numbers 1 – 9.
- The **2020 NEC** states - Ground-fault circuit-interrupter protection for personnel shall be provided as required in **210.8(A)** through **(F)**. Letters **(A)** through **(F)** are first level subdivisions, this section contains six subdivisions, with the letter **(A)** applying to **Dwelling units** consisting of eleven list items, numbers 1 – 11.
- The **2023 NEC** states - A listed Class A GFCI shall provide protection in accordance with **210.8(A)** through **(F)**. Similar to the 2020 NEC, this section contains six first level subdivisions, **(A)** through **(F)**, with

the letter **(A)** applying to **Dwelling Units** consisting of twelve List items, numbers 1 – 12.

The purpose for reviewing these three sections across two code cycles is to show that a new first-level subdivision and additional list items have become new requirements. What has not changed is that the ground-fault circuit interrupter shall be installed in a readily accessible location.

To assist in a smooth transition through two code cycles and six years of time while comfortably adjusting to the new minimum requirements of the NEC, the **IBEW-NECA Electrical Training Alliance** - have resources available to be used in combination with the 2020 and 2023 NEC code books. These textbooks, known as the “**Significant Changes to the NEC**” are presented with an easy-to-use format that show the most significant revisions and new requirements. Each change focuses on the “**Code Language**”, “**Change Summary**” and an explanation of the “**Significance of the Change**” and includes photos to help understand the code change. The Significant Changes to the NEC can be purchased at the JATC and I highly recom-

mend these books to meet the requirements of **Article 90**, specifically **90.2(A) Practical Safeguarding**. The **2023** edition of the **National Electrical Code** certainly meets the **purpose of the code** – sensible revisions reflecting advances in technology along with industry practices for the practical safeguarding of persons and property from hazards arising from the use of electricity.





## Did You Know?


